INFORMATION TO ENTRANCE THE UNIVERSITY

The student campus of the university includes 11 comfortable dormitories, a canteen for 1000 places, an Internet cafe, a medical center, a billiard club "Aviator". A foreign student is given a place at the dormitory for an additional fee. For this reason, a separate contract is concluded. The cost of living in a dormitory depends on the comfort conditions and is approximately \$ 60 to \$ 200 a month.

Expenses related to meals, transport, etc. in Kyiv do not exceed \$ 350 a month.
