EMPLOYMENT:

REQUIRED DOCUMENTS SUBMITTED FOR ADMISSION TO THE 1ST COURSE:

- ✓ Copy of identity document / birth certificate (3 pcs., 5 pcs. - for those who plan to live in a dormitory);
- ✓ Extract from the Unified State Demographic Register for registration of residence (who has a plastic passport!) (2 copies);
- ✓ Copy of identification code (3 pcs., 5 pcs. - for those who plan to live in a dormitory);
- ✓ A document of the state standard on the previously obtained educational level, on the basis of which the admission is made, and a copy of the appendix to it (2 pcs.);
- ✓ Certificate (certificates) of external independent evaluation;
- ✓ Information card (with external evaluation points);
- ✓ Medical certificate form O-086 (U-086) (original + 1 copy);
- ✓ Military ID or temporary ID (instead of military ID) - for conscripts; certificate of registration to the conscription station - for conscripts (original + 1 copy);
- ✓ Documents confirming the entrant's right to participate in the competition by the results of entrance exams on the basis of complete general secondary education, enrollment by interview, enrollment by quotas-1, quotas-2 or quotas-3 (if available) (original + 1 copy);
- ✓ Color photos of 3 x 4 cm (4 pcs., 6 pcs. - for those who plan to live in a dormitory).
- ✓ Certificate of RC for those categories of persons living in rural areas (if available) (original + 1 copy).

Note: when submitting copies, the original documents must be available; originals of documents when participating in the competition are submitted by the entrant only once (fulfillment of enrollment requirements).
